## Fall Billing

Fall 2009 pre-registration E-bills will be generated on July 14, 2009 and will be due August 6, 2009. Students and Authorized Users will receive an email when the E-bill is available.

## E-refunds – New Refund Process

**Effective July 1, 2009** electronic refunds will be issued directly from the University into your checking or savings account. **Higher One will no longer be used to issue student refunds.** Students will need to enter their bank account information into Sea Net/E-bill to receive any excess funds from loans, overpayments, scholarships and grant monies. **We cannot withdraw from this account.** The electronic refund system is safe and secure.
