2009 – 2010 Tuition Rates

The 2009-2010 rates for tuition and fees approved by the UNC Board of Governors are reflected in your July statements. Additional tuition rate increases are being considered by the NC General Assembly which could result in a change to the final tuition amount charged. Any adjustments to the tuition will be reflected in the September statement. Students and Authorized Users will be kept informed by e-mail when a final decision has been reached. Payment Plan Deadline – Fall 5 or 10 pay	Aug 6
PAYMENT DUE	Aug 6
Pre-reg cancellation – students notified by e-mail	Aug 8
SeaNet opens for regular term registration	Aug 14
Payment Plan Deadline – Fall 3 pay	Aug 26
Classes begin	Aug 19
End of Drop/Add Period – All payments Due	Aug 26

* Students that do not register for classes until after August 6, 2009 must pay in full by August 26, 2009.

E-refunds – New Refund Process

Electronic refunds are now issued directly from the University into your checking or savings account. **Higher One is no longer used to issue student refunds**. Students will need to enter their bank account information into Sea Net/E-bill to receive any excess funds from loans, overpayments, scholarships and grant monies. **We cannot withdraw from this account**. The electronic refund system is safe and secure.
