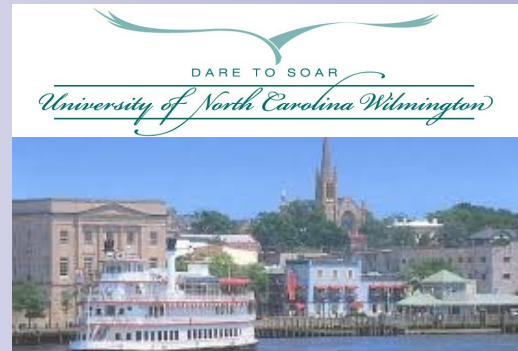

## All New Financial Aid Students! (Freshman, Transfer and Students receiving aid for the first time)

**Your financial aid WILL NOT disburse to your student account until action is taken. Please read carefully.**

**ALL New financial aid students must submit a Title IV Authorization.** You must answer "YES" or "NO" to the following two questions:

1. **Authorization to Apply Federal Financial Aid to Non-Institutional Charges**
2. **Authorization to Apply Current Federal Financial Aid (up to \$200) to Prior Year Charges**

In order to ensure that your financial aid is disbursed on time and any anticipated E-refunds are received by the first day of classes, **you must complete this action no later than Monday, August 11, 2014.** Failure to complete this action by the deadline date above may result in a delay in disbursement of your financial aid, as well as, any anticipated refund. Further, if you do not complete the Title IV authorization by **August 29, 2014,** your classes are subject to cancellation.

## *What are **BOOKSTORE DOLLARS** ?*

*This program allows students to charge books and related school supplies to their student account up to \$700 each Fall and Spring and \$300 for both summer sessions. Please visit this [website](#) for enrollment and more.*

## Refunds

August 13-15: Refunds will be posted to student accounts in preparation of disbursement.

August 20 – The first day E-refunds will be available in student checking/savings accounts.

If you have not already done so, please setup your E-refund account now via [E-bill](#). Failure to set up an E-refund account will result in a check that can be picked up on Fridays from 2-4 PM only.
