Summer I and II TealPay 3 Payment Plan will be available in May. More information will be provided in the April newsletter.

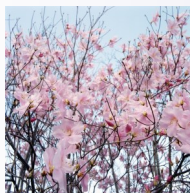

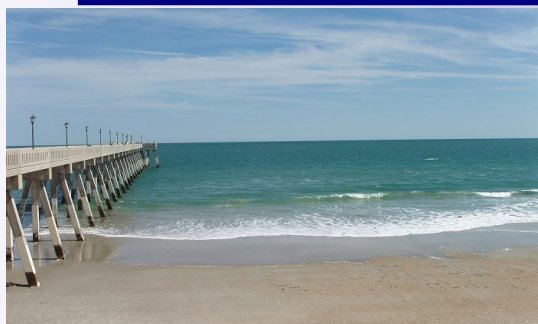


## Spring 2014 Tuition Surcharges
