Student Refunds

In preparation for issuing the Financial Aid refunds on the first day of class, the Student Accounts Office begins posting refunds to student accounts 10 days before classes start. Students will need to establish an E-refund account on the E-bill site to receive any excess funds from loans, overpayments, scholarships and grant monies. Set up your E-refund account today to avoid future delays due to paper check processing.

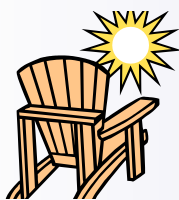
Students receiving refunds must understand that they may need to use their financial aid refund to pay any additional charges incurred on their student account after the refund has been processed.

Graduating Students—Important Information!!

Check your [E-bill](#) account to be sure you have a \$0.00 balance. Students with account balances receive a hold and will not receive their transcript or diploma (but may participate in graduation ceremonies).

Make a note for 1098-T purposes - if you pre-registered for Spring 2014 classes your transactions most likely posted to your account in calendar year 2013. If this is the case, you will NOT receive a 2014 1098-T tax statement in January 2015.

If you have tuition and fee transactions and/or scholarship and grant activity in calendar year 2014 please:

- Consent to an online 1098-T in [E-bill](#) - under "My Account" select "My Profiles", select "Paperless Options", consent to an online 1098-T statement.
- Make note of your E-bill username and password. You will need to remember your information in order to login to E-bill and view your 1098-T.
