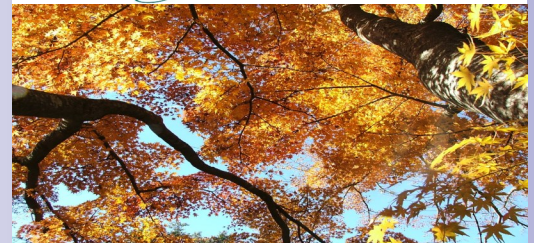
Student Finances First

## Attention Financial Aid Students!

If you have not already done so this fall, **ALL financial aid students must submit an online Title IV Authorization Form.** This form can be accessed through [SEANET](#). You must answer "YES" or "NO" to the following two questions:

1. Authorization to Apply Federal Financial Aid to Non-Institutional Charges
2. Authorization to Apply Current Federal Financial Aid (up to \$200) to Prior Year Charges

Failure to complete this action may result in a delay in disbursement of your spring financial aid, as well as, any anticipated refund.

## Have you consented to receive your 2013 1098-T tax form electronically?

- ◆ The first time you log into the E-bill system you will be prompted to Accept Consent to state your intent to receive your 1098-T tax form electronically for each year that you attend UNCW.
- ◆ Providing consent will enable you to log into E-bill to print, email or save your 1098-T.
- ◆ With this consent for an online electronic 1098-T, please understand that a paper copy of your 1098-T will NOT be mailed.
- ◆ If your authorized user needs the 1098-T you will need to select your Authorized User tab and update the options to allow them to have access to this form.
- ◆ Be sure to verify that your address is accurate in SEANET.
