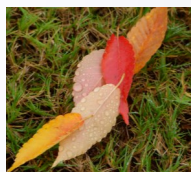
TealPay plans do not roll from one term to the next. Spring plans open for enrollment beginning Nov 18th.

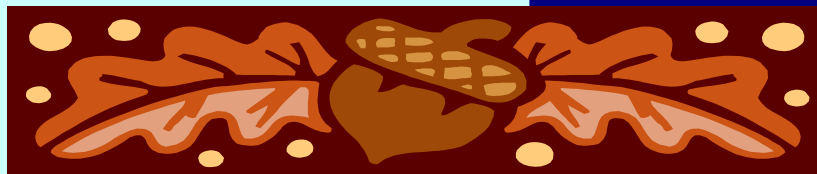
